



## **Hibel National Conference Scholarships**

Thanks to a generous gift from Elizabeth and Andrew Hibel, CCPG is pleased to be offering one scholarship to CCPG members to attend the 2020 National Association of Charitable Gift Planners Conference. The scholarship will include:

1. Attendance at the Virtual CGP National Conference
2. One-year CGP membership

Hibel National Conference Scholarships is available to fundraising professionals, planned giving consultants and allied professionals of all experience levels. Successful applicants will demonstrate a commitment to expanding their fundraising knowledge, an understanding of the value of networking with gift planning professionals on a national level, and a willingness to utilize the skills attained to improve philanthropy at their charitable organization and to further their career in the gift planning arena. Applicants must also demonstrate that their supervisor/organization will permit the applicant to attend the conference.

You must be a current CCPG member in good standing (no outstanding dues or program fees) to apply. Current CCPG Board Members and Outreach Committee members are not eligible, however, former board or committee members may apply.

Preference will be given to individuals who have never attended the National Conference or who have not attended within the past 5 years. CCPG encourages applications from individuals from diverse backgrounds and from professionals who represent organizations serving traditionally underserved and/or under-represented individuals.

Current and former CCPG Scholars are eligible and encouraged to apply. While there will not be a slot exclusively designated for CCPG Scholars, preference for one of the four scholarships may be given to a current or recent CCPG Scholar.
